#### **Open Discussion**

**Spring Newsletter.** Mary Roodenburg shared a computer problem in creating the Spring Newsletter. Both Cindy and Mary Kummer agreed to assist. Cindy, who uses a MAC will try to set up the format based on Mary R. sharing her current version. The Board agreed to push the publication back to May and announce the confirmed location for Beer & Wine. **ACTION:** Cindy will work to create the newsletter. Mary and other Board Members will assist as necessary.

**Wine and Beer Event:** Fundraiser will be on June 12th. Location is to be determined. Both Chris Ivers and Julie Meyers offered the use of their yards if we are unable to find another location.
